## Social Membership

### Please Keep for Your Records

As a **social** member, you will be entitled to use all the clubhouse facilities of Old Hickory Golf Club (the “Club”). Please identify yourself by name and or member number to your server/bartender when ordering.

- Members receive a 10% discount on food and beverage purchases. It is important to keep copies of all receipts to verify your charges. The Club has the right to modify payment terms from time to time.
- Social members will receive an Old Hickory Golf Club newsletter that will include a calendar of events. You are welcome to attend all member events that are **non-golf related**.
- Meeting rooms are available for private parties, business meetings, and other functions. Arrangements must be booked in advance, and minimum purchases and room charges may apply, ask event staff for details.
- Access to the “members only section” of our website, [www.oldhickorygc.com](http://www.oldhickorygc.com). You will receive a password and will be prompted to change it the first time you are logged on. You may check our calendars and view the newsletter online.
- Social members are able to play golf twice per calendar year at \$75 plus sales tax, which includes cart fee. You are able to bring 3 guests each time you play at the same rate of \$75 plus tax per person. It is necessary to make a tee time by contacting the pro-shop. Golf lessons, clinics, large and small golf outings are available by contacting the Director of Golf. **The driving range is available only when you play golf.**
- Converting from a Social Membership to a Golf Membership may be done at anytime by contacting the Membership Office for details.
- You may resign from the Club by giving thirty days advance written notice to the Club and pay any outstanding dues or other charges. Your membership may be terminated by the Club as a result of any violation of the Club’s Rules and Regulations as determined solely by the Club. Your membership in the Club may not be transferred.

Terms and conditions are subject to change for all Membership Classifications. Your membership is not an investment in the Club, nor does it provide an equity or ownership interest in the Club or any of the Club Facilities. Membership in the Club does not confer upon you as a member a vested or prescriptive right or easement to use the Club Facilities. The Club’s management has the right to restrict or reserve the Club for maintenance, tournament play or other special events. Membership in the Club is a revocable license only and is subject to suspension and revocation for failure to abide by the Club’s Rules and Regulations as now in effect or as may be amended.
